I was born in Ithaca, NY when my Dad was in grad school at Cornell, and raised in Auburn, Alabama where by Dad was on the Auburn University faculty. I am trained in biological sciences and the law with degrees from Auburn University (BS), University of Colorado, Boulder (MS), and Duke University (JD). I am married to Vickie Martin and we have a daughter Emily.

Since graduating law school I clerked for a Federal Court of Appeals for one year, and practiced law in two law firms in North Carolina: Moore & Van Allen, PLLC, and Harlow, Evans & London after completing my clerkship. In 1999 I left the private practice of law and accepted a job as a senior attorney in the intellectual property group of the Hewlett Packard legal department. A few months later, HP spun out Agilent Technologies, and I have been a patent attorney in the Agilent legal department ever since.

I was admitted to the North Carolina Bar in 1983, before the US Patent and Trademark Office in 1988, and was admitted to the California Bar in 2001. Since around 1990 my career focused primarily but not exclusively on intellectual property matters.

Prior to this my legal experience was quite broad for an associate and partner in a mid-sized corporate law firm. My experience included incorporation, by-law drafting, and advising both for profit and not for profit corporations, lender representation in lender liability issues, shareholder agreements, and significant litigation experience in both the state and federal courts.

Even after choosing to emphasize intellectual property law in my practice, I continued to represent several long term clients, such as a couple of NC-based resort developers and NationsBank (now Bank of America) on various legal issues relating to coastal development, including resort development financing, Coastal Area Management Issues, environmental law issues, and certain other large scale real estate financing matters.

My outside interests include bicycling, yoga, hiking and reading. My volunteer work is primarily with a non-profit Kriya Yoga teaching and meditation center in San Jose called the Center for Spiritual Enlightenment (CSE) where it has included a variety of volunteer positions, including 6 years on the CSE Board of Directors. I have been off the CSE Board for the past two years.
